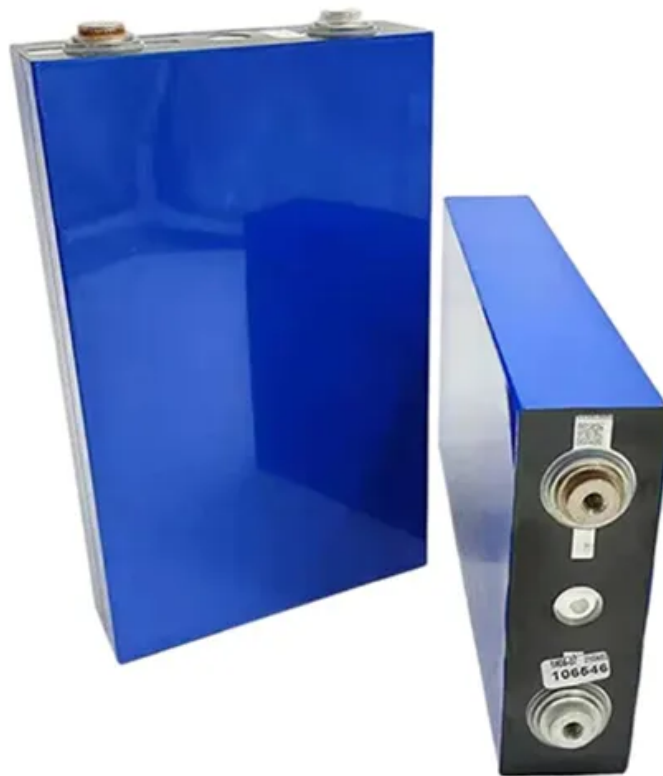

How does an energy generator export limitation scheme work?

How It Works: When an energy generator's export capacity needs to be restricted, an export limitation scheme is implemented. This scheme measures the Apparent Power (in kilowatts) at the installation's exit point.

What are the compliance requirements for energy storage systems?

Compliance Requirements: Power Quality Standards: Export Limitation Schemes must comply with relevant power quality standards. ER G100: Generation and energy storage systems must adhere to ER G100 guidelines. ER G98 and G99: Depending on the type of installation, compliance with ER G98 and G99 may also be necessary. 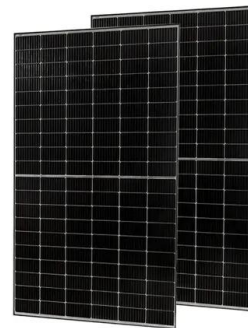
